Businesses, Professionals, and Financials located outside of Eau Claire County\*\* pay fifty percent (50%) of the Membership Investment Schedule, but not less than the minimum Business Category Base Rate of \$334.

\*\*The north side of the City of Eau Claire, including the Chippewa Valley Industrial Park, extends into Chippewa County. Businesses within this area fall under the standard Membership Investment Schedule.

The Board of Directors of the Chamber of Commerce developed the above categories to assure fair and equitable financial participation by all members. Areas not covered in these categories will be reviewed on a case-by-case basis by the Chamber Board of Directors.
